

## VETERINARY FEES SCHEME FOR MARES VISITING: THORNWICK CHALLENGER & FLAYNE DON DAIQUIRI AT WEST END FARM STUD

### 3 CYCLES

This is an optional scheme where the mare owner pays a 'one-off' fee to cover the costs of veterinary work necessary to help get your mare in foal and monitoring the development of the early pregnancy (details of the few procedures excluded follows).

The advantages for you, as a mare owner, are a **fixed single fee with discount for prompt payment**. Many mares need considerable monitoring and treatment after covering in addition to the routine swabbing and monitoring before covering necessary for all mares. The costs of this can soon mount up, but if you are on a veterinary scheme, all these procedures are already paid for, enabling you to know your outlay on veterinary fees for that breeding season regardless of the amount of veterinary work involved. Over the years, as a veterinary practice specialising in equine breeding work, we have found this offers the best approach to getting mares in foal as early as possible in the breeding season.

***Even if your mare has normally been relatively straightforward to get in foal, we recommend our veterinary scheme as unforeseen problems may arise.***

Any particular requirements or suggestions you may have regarding the veterinary care for your mare should be communicated to us at the practice:

The cost of the scheme is £370 plus VAT, if payment is received within 28 days of the first invoice. If payment is not received within this 28-day period then the full price of £420 plus VAT will be charged.

All mares visiting the stud should ideally have a clitoral swab taken. Mares arriving without this certificate will be clitoral swabbed on arrival.

Following is a detailed breakdown of the procedures included in the scheme. If you have any queries please do not hesitate to contact us.

If these forms are not returned within one month of being sent or given to you we shall assume that your mare is not on the scheme and your veterinary work will be invoiced when done.

***Veterinary Fees included:***

CEM swab & Lab Fee, examine genital organs; all scans; hormone injections; Caslick's operation; pregnancy diagnosis at 14 to 16 days, 24 to 28 days and 36 days; crushing of one conceptus in sets of twins.

**This scheme will apply for covering up to three separate heat periods.** The scheme only applies to the current breeding season and for mares at West End Farm Stud using resident stallions.

***Veterinary Fees NOT included:***

Visit fee to West End Farm Stud, Blood test for Equine Viral Arteritis (EVA) and Equine Infectious Anaemia (EIA), Attention at foaling. Treatment for injury, illness or lameness; second opinions and further outside investigations; opening Caslick's in pregnant mares; insurance examination; regumate treatment; care of sick foal; surgical procedures; attendance at foaling; routine vaccinations; pregnancy tests after 42 days; fetal sexing; blood typing & identity/microchipping. Any sedation considered necessary for mare and/or personnel safety is **NOT** included.

The hormone **buserelin** (Veterelin/Busol/Receptal) is useful in mares with a history of losing the pregnancy. The hormone is given as a single injection and costs approximately £21. This is NOT included in the scheme

Owners should indicate when sending mares to West End Farm Stud whether they wish to take up the scheme.

Fees payable at the end of the month of arrival of mare/mare & foal at the stud.

**The lower fee will only apply if payment received in this first month after invoicing.**

If payment is not received within this 28-day period then the full price of £420 plus VAT will be charged.

Owners will be invoiced monthly for any items not included in the scheme.

Owners not taking up the Veterinary Fees scheme will be invoiced monthly for all work undertaken. All charges are subject to VAT if applicable.

## TERMS & CONDITIONS

We (Equine Reproductive Services (UK) Ltd) are a general equine veterinary practice which specialises in equine reproduction. We provide a 24 hour veterinary service. Our aim is to provide a high quality of veterinary attention to horses under our care. We are experienced in techniques to achieve and maintain a healthy equine pregnancy and the care of the foal. We will endeavour to provide veterinary services in accordance with reasonable standards denoted in the RCVS guidelines for practice standards and the professional conduct of veterinary surgeons.

### General terms for horses at stud:

The stud which your (the owner or agent of the horse) mare or foal is resident will be responsible for the daily husbandry and care of your horse and/or foal. Upon verbal or written request by you or the stud we will provide veterinary services and invoice you for goods and services provided, unless previously advised otherwise in writing.

Emergency procedures requiring referral, surgery or general anaesthesia will be performed after consultation with you. If contact cannot be made appropriate treatment will be provided to protect the welfare of your horse, if the services of other veterinary surgeons are enlisted you will be liable for their fees. If your horse is insured you should advise either us or the stud when leaving your mare. The vulva of any mare may be sutured if considered necessary unless written instructions are received to the contrary before arrival of the mare at stud.

We recommend you to contact the stud regularly regarding progress with your mare. We welcome contact with you to discuss any aspect of your mare's veterinary care whilst she is at stud please telephone us during office hours (08:30 -12:00 weekdays).

### Payment terms:

All our fees and medical charges are subject to VAT at the current rate. Our fee levels are determined by the time spent on a case and according to the medicines, materials, and consumables used. A written estimate is available on request. Any new client will be expected to pay in full at the time of treatment. Treatment on account will only be available to established clients known to us with a sound credit history.

Our clients will be invoiced monthly however we reserve the right to interim bill. Payment may be required on account of our professional fees before work can commence in certain circumstances. Please also bear in mind that if bills are not paid in accordance with our credit terms we may not continue to work on your horse until you have settled your account. We have a statutory right to charge interest on the amount of the bill after expiration of one month from the date hereof. Such interest will be charged by us at a rate of 8% if payment is not made within one month

Credit terms are 28 days from receipt of invoice. Credit card payments will incur a 2.5% surcharge.

Any cheque returned by our bank as unpaid, any credit card payment not honoured, and any cash tendered and found to be counterfeit will result in the original account being restored to the original sum with further charges added in respect of the bank charges and administrative costs.

This Agreement can be terminated by you at any time in writing or by us on the occasion of any of the following events: You fail to provide us with instructions on request, or you fail to pay an account delivered within 30 days, or on our giving you notice in writing
